(1) For the right to operate a Concession at the Airport for a period of two (2) years, the Bidder offers to pay 10% of the Gross Revenue as that term is defined in the Specimen Concession Agreement, but in any event will pay at least the following "Minimum Annual Guarantee", for each Contract Year of the Concession Agreement and subject only to termination or abatement under the terms of the Concession Agreement and not otherwise:

It is understood that Bidder will be given written notice if awarded the Concession based upon this Bid. Such notification shall include two (2) copies of the Concession Agreement, and two (2) copies of the Service Facility Agreement together with a statement of the insurance coverage required by the Authority. Bidder agrees to fully execute and deliver two (2) copies of the Concession Agreement and Service Facility Agreement; a Performance and Payment Bond in the form attached to the Solicitation, and certificates evidencing all insurance coverage required under the Concession Agreement and Service Facility Agreement together with satisfactory proof of execution within thirty (30) days of the date of mailing stated in the notice.

If any of the language or information in this Bid conflicts with the Solicitation or any of the documents furnished with the Solicitation, the language of the Solicitation or of the applicable documents shall govern.

The Bidder further agrees that, in the event the Concession is awarded to him/her and he/she fails to comply with all of the requirements of the preceding paragraphs, as applicable, the Bid Guaranty shall be forfeited to the Authority.
